THE LATEST FODARA BENEFITS NEWS: FIVE ITEMS

Below is the latest-breaking benefits news for all of you far-flung FHDA retirees.

Voluntary MetLife Insurance

The Joint Labor-Management Benefits Council (JLMBC) is planning to offer a suite of four voluntary insurance products from Metropolitan Life Insurance Company (MetLife) during the next open enrollment period, which will be September and October for the 2016 Plan Year.

Two of them (Legal and Pet Insurance) will be available to FHDA retirees while all four (Legal, Pet Insurance, Critical Illness, and Accident) will be available to actives, each at group rates. Actives will have their voluntary premiums paid by payroll deductions while retirees will be direct billed. The key word here is "voluntary"; pay the premiums for the policy if you want it, otherwise, forget it.

Legal Services - MetLaw



The Legal Services policy costs \$19.50 per month and covers spouse and dependents. This policy provides access to a nationwide network of over

13,000 vetted attorneys for a wide variety of legal matters, including the following:

- Estate Planning (Wills, Living Wills, Trusts)
- Home and Real Estate (Sale, Purchase, Refinance, Assessment, Foreclosure)
- Money Matters (Identity Theft, Creditor Negotiations, Tax Audit Representation)
- Family and Personal (Adoption, Prenuptial Agreements)
- Civil Lawsuits (Civil Litigation, Small Claims Assistance, Pet Liabilities)
- Elder (Parental) Care Issues (Medicare, Nursing Home Agreements, Power of Attorney)
- Vehicle and Driving (Traffic Ticket Defense, DUI License Suspension, Vehicle Repossession)

MetLaw provides unlimited access with no usage limits, no deductibles, no claim forms or co-pays. All billing is between the network attorneys and MetLife. Additional information on MetLaw will be provided to retirees prior to the next open enrollment period.

❖ Pet Insurance



MetLife offers several pet insurance plans with different coverage options (no annual deductible vs. \$250 annual deductible; \$500 maximum annual

benefit vs. \$14,000 annual benefit; etc.) and premiums to insure your dog or cat (you FHDA retirees with a pet horse, mule, or gerbil have to look elsewhere to insure Trigger). The plans are too complex to summarize here, and the premiums depend the pet species (e.g., miniature on chihuahua vs. wolf hound) and the coverage chosen. Pet insurance is a competitive business with many good policies in the market. Why not ask your veterinarian for a recommendation? More information on the MetLife pet insurance policies will be coming your way before the next open enrollment period.

❖ Affordable Care Act (ACA) Cadillac Excise Tax

This next item is simply an advisory intended to keep you informed. You don't have to do anything. It's technical, but some of you may be interested. The Affordable Care Act, a.k.a. "ObamaCare," has a provision that levies an excise tax starting in 2018 on plan administrators (in our case,

on the FHDA District) for offering health care plans with very high total values (premiums) which makes them "Cadillac Plans." If in 2018 FHDA offers any heath care plan with a CalPERS annual premium (as opposed to a retiree contribution) over \$10,200 for a single retiree, \$27,500 for a retiree plus one, or \$27,500 for a family, then FHDA will be levied a 40 percent excise tax on the excess over these premium limits.

For example, in 2015, the full CalPERS annual premium for a single FHDA retiree living in the Bay Area who is covered by Kaiser, but is not on Medicare, is \$8,568 (12 x \$714). In contrast, the required contribution—what the retiree pays the District for this coverage—is \$1,224 (12 x \$102). Now, if the CalPERS annual premium were to grow at an 11 percent compound rate for three years, in 2018 the premium would be \$11,718 (\$8,568 x 111% x 111% x 111%) thus exceed the \$10,200 limit by \$1,518 (\$11,718 - \$10,200). The FHDA District would then be charged \$607 (40% x \$1,518) for each retiree it offers this Cadillac plan.

The reality is that an 11 percent annual increase is probably too high. For projection purposes (see below), Lockton, the District's health care consulting firm, and JLMBC use 7 percent as a recent average value. Further, CalPERS is aware of the looming Cadillac tax, and in all probability will limit its premium increases (perhaps by somehow contracting coverage) to stay under the ACA excise tax limits.

❖ 2016 Projections

JLMBC is assessing multiple scenarios with the help of Lockton analysts to plan for 2016. It works like this. The baseline are the actuals for 2015. The 2015 "expenses" are found using current enrollments and the current CalPERS premiums for each health

care plan, plus Delta Dental and VSP premium for each enrollee (there are other expenses, but these are the major ones).

The 2015 "income" is found by totaling all the employee/retiree contributions plus the \$976/month per employee/retiree the District pays for benefits by union contract. For 2015, the average premium cost was \$1,038 PEPM (Per Employee/retiree Per Month), average dental was \$137 PEPM, and average vision was \$17 PEPM.

1,790 employees/retirees, With approximate total 2015 expenses were \$25,600,000 (1,790 x 12 x [\$1,038 + \$137 + \$17]). The 2015 average employee/retiree contribution was \$203 PEPM, so the approximate 2015 "income" was $$25,300,000 (1,790 \times 12 \times [$203 + $976]).$ This leaves a shortfall of \$300,000 (\$25,600,000 - \$25,300,00), which comes out of Fund 61, the Benefits Stabilization fund with a current balance of about \$10.3 million.

Using this baseline, the voting District representatives and/or union propose employee/retiree required changes to contribution rates and/or District benefits payments under contract (currently \$976 PEPM). Next, using projected enrollment for 2016 and CalPERS premium rates (currently assumed to increase an average of 7 percent—CalPERS announces actual 2016 rates in mid-June), Lockton generates spreadsheets to show the impact on each employee/retiree group, the District, and Fund 61. It's then up to the JLMBC voting members (that excludes FODARA since we're advisory) to negotiate a compromise that everyone can accept.
